Modern challenges such as population growth, urbanization, climate change, increasing inequalities and poverty call for new approaches that must start from school education and that are able to highlight and create, when necessary,

harmony among peoples and between humans and nature, meaning dignity, well-being and sustainability. Culture plays an important role in this process as it offers a framework to build equal sustainable development according to UNESCO's Hangzhou Declaration (2013). Music is a cultural expression common to all nationalities and it has the power to bring added value to pupils' learning experience and self-development if integrated properly in curricular activities.

The UNESCO's Hangzhou Declaration words have never been closer to the truth, now, in the pandemic caused by Covid-19. Music has to become a tool to be integrated into disaster-risk reduction and inclusion policies applicable by schools; a common means to appeal to younger generations and motivate them towards their academic and personal success; a chance to support knowledge transfer among educators in a cross-disciplinary approach. The project "LE.IT.M.O.T.I.V. – LEarning how to InTegrate Music in schOol Through International Ventures" stems from such reasons and from the expertise of the Art School "C. Brailoiu" in teaching Music but it also embeds the missions of the other partner schools: the Turskish "Bergama Cumhuriyet Anadolu Lisesi" with its experience in STEM didactics; the Finnish "Hyvinkään yhteiskoulun lukio" with the high results achieved in teaching foreign languages; the Portuguese "Escola Básica de Pedome" with its previous experiences in European projects.

The project "LE.IT.M.O.T.I.V." aims at strengthening the resilience of 84 young learners (aged 15-18) of different nationalities through training activities developed in transnational mode, hosted in turns by each of the partner school engaged in this Strategic Partnership; 7 pupils will be selected by each school for each LTTA, but when hosting, the schools will still involve 7 local students so that actual number of pupils involved will increase to 112.

The activities will be organized during 4 international exchanges lasting 5 days, plus 2 days destined to travel arrangements from and to the Hosting Countries: Romania, Turkey, Finland and Portugal. The groups of students will be accompanied by 2 teachers from each school (for a total of 6 educators representing the school staff). The project will foresee the creation of 2 concrete outputs, one realized by teachers and the other by pupils:

- -O1: translations of the European Agenda for Music into new languages;
- -O2: an online course for the Teacher Academy of School Education Gateway.

The objectives of the present project proposal will be:

- -to deepen the idea of European citizenship among students of different nationalities through the common value given by music as part of one's own artistic and cultural heritage;
- -to motivate students towards the learning process by experimenting ways to integrate music in the teaching of curricular subjects (second language, stem disciplines, art, sport, etc.);
- -to design innovative educational paths that can innovate the teaching standards and produce added value in terms of a more integrating and inclusive didactics;
- -to strengthen the internationalization strategy of the European schools involved;
- -to spread the use of digital tools to integrate the teaching process (i.e. virtual exchanges on eTwinning).

The project will produce positive impacts, to be measure in the short and medium-long term:

- -to enhance pupils' motivation towards the learning of STEM disciplines, foreign languages, Art and Sport through the effective integration of Music as learning tool;
- -to sensitize educational stakeholders and schools towards a more conscious perception of Music as a support participatory and innovative didactics;
- -to speed the internationalization process of the partner schools involved by empowering its staff's language/digital skills throughout the project lifespan as well as by enriching their curriculum with an additional management experience in the framework of the Erasmus+ Programme;
- -to foster new didactic activities, transnational projects and virtual exchanges will stem from the cooperation among the partner schools to enhance the quality of teaching.

The Art School "Constantin Brailoiu", in the district of Târgu-JiuGorj (the Oltenia region of Romania), is a vocational school and among its curricula, it counts studies concerning the teaching of music, visual arts, drama and architecture. It includes different levels of education: primary, middle and high school. The Art School "C. Brailoiu" has 96 teachers and 520 pupils (aged 6-18). The school pursues, with great interest and a creative mind, the developments in the field of education; it constantly sets new goals holding at the same time an outstanding position in the educational scene. Lots of students who graduated from the school curricula managed to find work in music orchestras, as teachers, in artistic education, or as soloists.

Through the use of the most up-to-date facilities, a diverse curriculum, experienced and skilled teaching staff and, most importantly, through consistency on principles and respect towards pupils and parents, the art school "C. The Agrupamento de Escolas de Pedome belongs to the municipality of Vila Nova de Famalicão, located in province of Minho, in the district of Braga, Portugal. Students who attend the school, and their families, largely reflect the socio-economic and socio-cultural reality surrounding them: social marginalization, poverty, lack of future perspectives, they are all aspects that affect students' school performance and life. The School registers problems related to failure and early school leaving, but also students neglected and mistreated. The school population is made up of 1566 students, with about 58% of then benefitting from social support and 87 students with special educational needs. The Agrupamento de Escolas de Pedome counts a total of 208 employees (139 teachers, 65 non teaching staff and 4 Specialized Technicians). Subjects taught in the school curricula are: exact science, social and human sciences, languages, music and sport education.

Modern challenges such as population growth, urbanization, climate change, increasing inequalities and poverty call for new approaches that must start from school education and that are able to highlight and create, when necessary, harmony among peoples and between humans and nature, meant as dignity, well-being and sustainability. Culture plays an important role in this process as it offers a framework to build equal sustainable development according to UNESCO's Hangzhou Declaration (2013). Music is a cultural expression common to all nationalities and it has the power to bring added value to pupils' learning experience and self-development if integrated properly in curricular activities.

The project "LE.IT.M.O.T.I.V. – LEarning how to InTegrate Music in schOol Through International Ventures" stems from the expertise of the Art School "C. Brailoiu" in teaching Music but it also embeds the missions of the other partner schools: the Turskish "Bergama Cumhuriyet Anadolu Lisesi" with its experience in STEM didactics; the Finnish "Hyvinkään yhteiskoulun lukio" with the high results achieved in teaching foreign languages; the Portuguese "Escola Básica de Pedome" with its previous experiences in European projects.

Everybody contributed to make this project as "transversal" as possible so for it to be like Music: diverse, accessible, usable.

The project should be funded because:

-in the 24 months of its duration, it will promote no. 4 international exchanges (Learning Teaching Training Activities) giving pupils, especially those with fewer opportunities, the chance to travel to a different Countries, to meet peers of different nationalities and improve their English, being the main language of exchange, while also acquire soft skills as life tools helping them facing future challenges;

-in its progressive management, the project will allow teachers supporting its actions to discover new teaching methods and acquire know-how in order to structure educational courses in non-formal and informal contexts, thus bringing added value to the pupils' learning process. This will be achieved thanks to the exchange of didactic approaches and ideas among the educators involved;

-in a period of extreme chaos and uncertainty, cooperation actions among schools are even more valuable. The threat of Coronavirus spreading all over in Romania and Europe does not only make Europeans questioning concepts such as those of mutual respect and intercultural acceptance, but will generate consequences that might negatively affect the perception of mobility in the long run. Music, as shared value, can really offer a "safe space" where young Europeans can find curiosity and motivation towards their own learning.

What are the objectives you would like to achieve and concrete results you would like to produce? How are these objectives linked to the priorities you have selected?

The UNESCO's Hangzhou Declaration (2013) keeps quoting "the safeguarding of relevant traditional knowledge, values and practices, in synergy with other scientific knowledge, enhances the resilience of communities to disasters [...] the feeling of normalcy, self-esteem, sense of place and confidence in the future among people and communities affected by disasters should be restored and strengthened through cultural programmes". These words have never been closer to the truth, now, in the pandemic caused by Covid-19. Then, the Declaration goes on highlighting the importance to "capitalize on culture to foster innovative and sustainable models of cooperation [...] at both the national and international levels, including grass-roots initiatives and culture-driven partnerships [...] while opportunities should be provided to develop capacities and transfer knowledge, notably through the sharing of best practices."

Music becomes a tool to be integrated into disaster-risk reduction and inclusion policies applicable by schools; a common means to appeal to younger generations and motivate them towards their academic and personal success; a chance to support knowledge transfer among educators in a cross-disciplinary approach. The project "LE.IT.M.O.T.I.V." was inspired by such principles and, in a time of rapid and profound changes, it aims at strengthening the resilience of 84 young learners (aged 15-18) of different nationalities through training activities developed in transnational mode, hosted in turns by each of the partner school engaged in this Strategic Partnership; the activities will be organized during 4 international exchanges lasting 5 days, plus 2 days destined to travel arrangements from and to the Hosting Countries: Romania, Turkey, Finland and Portugal. The project will foresee the creation of 2 concrete outputs, one realized by teachers and the other by pupils:

- -O1: translations of the European Agenda for Music into new languages;
- -O2: an online course for the Teacher Academy of School Education Gateway.

The objectives of the present project proposal are linked to the selected horizontal priorities:

(Social and educational value of European cultural heritage & Social inclusion)

- -to deepen the idea of European citizenship among students of different nationalities through the common value given by music as part of one's own artistic and cultural heritage;
- -to motivate students towards the learning process by experimenting ways to integrate music in the teaching of curricular subjects (second language, stem disciplines, art, sport, etc.) and to actively foster their inclusion. (Strengthening the profiles of the teaching professions)
- -to design innovative educational paths that can innovate the teaching standards and produce added value in terms of a more integrating and inclusive didactics;
- -to strengthen the internationalization strategy of the European schools involved;
- -to spread the use of digital tools to integrate the teaching process.

How are the planned activities going to lead to achievement of the project's objectives ?

The project's objectives will be achieved through the development of training activities (whose core will be 4 international exchanges) that will foresee tasks and teaching techniques specifically created to actively engage learners in their learning and improvement.

Pre-mobility preparatory phases will be partly developed at each school's premises, partly on eTwinning through virtual exchanges, which will serve to project students towards a wider European dimension and favor their team work (activities will be based on the themes of the European Agenda for Music). This measure will contribute to the project objective to spread the use of digital tools to be integrated within the teaching process.

The project will proceed with the development of 4 international exchanges abroad, during which pupils will be engaged in tasks integrating ICT and practical educational strategies (learning by doing, cooperative e-learning and project-based learning), aimed at improving their approach to STEM disciplines (LTTA C1), L2 (LTTA C2), sport and well-being (LTTA C3) and art (LTTA C4) through music. By acting in teams, speaking a foreign language, solving problems and exercises, investigating on the web, and assessing themselves, students will increase their motivation and key competences such as learning to learn, sense of initiative and cultural awareness. On the one hand, while working on O1 (translations of the European Agenda for Music into Turkish, Portuguese, Romanian and Finnish) in between LTTAs, students will follow a real cognitive path and learn more about the modern role of music in Europe; on the other, the realization of O2 will allow the wider engagement of each partner school staff (during the project activities, teachers from the NT, accompanying teachers, but also educators indirectly engaged will gather material and evidences to structure an online course for SEG Teacher Academy) and the sustainability of the project actions. At the same time, teachers engaged in the organization of the Learning Teaching Training Activities, from the project meetings, the arrangements of pupils' (virtual) exchanges and the related educational activities - as well as those accompanying students abroad - will develop practical knowledge and management skills (risk resolution, empathy, motivation) necessary to radically change their approach to teaching and to strengthen the internationalization strategy of their own schools.

During the realization of "LE.IT.M.O.T.I.V.", the project partnership will use the platforms made available by the European Commission and by the Erasmus+ Programme as follows:

- 1) eTwinning will be a fundamental tool for the development of the project activities in order to guarantee the realization of the transnational cooperation among the students and teachers involved, especially during the phases in which they will not have the opportunity to meet in person, before and after each mobility. A specific Twin Space destined to the project will therefore be created to share the description of all the project activities and different phases. Each partner school will access the platform in order to use the chat tools and forums discussion to develop the planned tasks. eTwinning will also be used for dissemination purposes through the promotion of all the project results on the Twin Space, where the materials produced during the transnational exchanges will be collected as digital repository; participants, both teachers and students, will also have the opportunity to participate in virtual exchanges throughout the project duration;
- 2) the School Education Gateway will be used as a tool for testing and researching; in fact, one of the project Outputs will be the creation of a MOOC for the SEG platform. The MOOC will be created by all the teachers involved in the project activities that, after collecting tasks and evidences, will be able to enrich the MOOC with concrete tips and didactic methodologies that other European teachers will benefit from when attending the course online. The MOOC will follow the structure of the other SEG courses and will be drafted with the support of teachers coming from each partner school, coordinated by the NTs, and sent to Teacher Academy Pedagogical Advisory Board for approval;
- 3) Erasmus+ Project Results Platform will be useful for the dissemination of the project and the results obtained. In case of approval, an Erasmus+ Project Card will be created on the platform and enriched with the project summary and the concise description of the foreseen activities and the transnational exchange phases, with brief overview on the expected results. The Project Card will be updated at the end of the 24 months of management with the material and outputs produced by the entire partnership.

As a matter of fact, one of the aims of the present Strategic Partnership is to improve the use of eTwinning as an integrative instrument of the partner schools' didactic planning: an Alumni Group will be created after the end of the project to keep fueling educators and teachers' debate and foster the creation of future eTwinning virtual exchanges, which will then constitute the common foundation where it will be possible to build new joint ventures on. Until then, it is necessary to start from scratch and, first, focus on the consolidation of management and collaboration mechanisms of a partnership made up of like-minded schools.

The project activities will involve 84 students (21 per partner school), aged 14-18, who will actively participate in the pre-mobility preparatory stages and in the LTTAs abroad. The introductory phase as well as the virtual exchanges on eTwinning will be open to other pupils who will show interest in the project dynamics (for a max. of 15 other students per school).

In order to ensure the widest promotion of the project activities and opportunities among the participating target and the different school communities involved, each National Team will organize and carry out Info-Days to clarify the project objectives and future impacts along with the procedures for submitting applications (families will be engaged as well so to make them fully aware of the project transnational nature).

The teachers composing each National Team will act "behind the scenes" to ensure a smooth-running management, developing organizational and planning skills (during the project meetings, for budgeting and reporting, in the exchange with the foreign partners, etc.) that will serve their own schools in their sustainable growth. Another way that the project will stimulate teachers' participation will be through the involvement of 6 teachers as "mobility facilitators", meaning accompanying persons, during the LTTAs; their full awareness will be activated through a preparation developed by the Applicant Art School "C. Brailoiu" for its experience in teaching music (the preparation will follow key themes and topics taken from the European Agenda for Music). Each partner school will arrange the selection process autonomously although following common guidelines: a

Call for Applications will help identify the students and teachers more motivated in participating; parents will sign an authorization to allow their sons and daughters to go on mobility.

A Selection Committee, made up of each NT and the Principals of each school partner, will evaluate the applications received based on the following criteria:

- -Motivation to take part in the experience, measured through one-to-one interviews (min. 5 max. 10 points);
- -Knowledge of English B1 will be the minimum CEFR level required, to be assessed on 1 receptive (listening) and 1 productive (speaking) skill (min. 10 - max. 20 points).

The students' families will be involved in all the project presentation events to keep them constantly updated on the progress of all activities; during the mobility abroad, accompanying teachers will ensure continuous communication with the participants' parents, who will take active part in the project dissemination by contributing to the sharing of project-related news online and through word of mouth.



#### How will you support these participants so that they will fully engage in the planned activities?

The different schools participating in the partnership have diverse backgrounds, but all register the presence of students who live uncomfortable conditions due to economic/geographical/social/cultural obstacles. Specifically: -the Applicant Art School "C. Brailoiu" is located far from the nearest big cities and has poor public transport connections which impede students from having the opportunity to meet foreigner peers and practice a foreign language; in addition, registering high rates of poverty (Oltenia region is indeed at high risk of poverty), students rarely have a chance to travel abroad, if not with support of external funds. Now, because of the threats of Coronavirus pending on the students' families and their income, the school needs to take advantage of the opportunities coming from Europe to give its pupils chances to develop skills that will help them in their personal growth;

-Bergama Cumhuriyet Anadolu Lisesi being a Turkish school and, hence, from an Erasmus+ Programme Country, is determined to participate in new cross-border collaborations to empower its capacity and prestige. Turkey is a country that still suffers from cultural misconceptions and stereotypes so its schools' determination in establishing good practices with other European organizations is strong and inspirational;

-the Escola Básica de Pedome, in the north of Portugal, in the district of Famalicão, has been following positive trends since 2011; youth crimes and deviant behaviors decreased as the quality of education improved, and the Portuguese school plans to maintain such positive trends by encouraging new and enriching learning possibilities for its pupils and opportunities of professional development for its teachers.

The full engagement of students with fewer opportunities will be ensured by the presence of their accompanying teachers, who will take care of their training and acclimation process abroad. Such target of students will instantly benefit from the practical approach promoted by the project, but, most importantly, in the long run, the skills built and the deeper awareness of their lifelong development will give them reinforcing tools to manage their future learning pathway. As for the Finnish partner school, "fewer opportunities" for pupils are reversed; indeed, Hyvinkään Yhteiskoulun Lukio registers a low percentage of students with migratory background, reducing the chances to promote multiculturalism; in order to promote cultural diversity and equality (being amongst the European Key competences), it needs new occasions (i.e. transnational learning activities in mobility) to ensure that its 21 students come into contact with peers from different nationalities with the goal to bring them closer to their peers and help them empower their ability and attitude towards intercultural dialogue.

The partner schools will develop the project phases on the basis of a precise division of tasks and responsibilities, as defined in the Memoranda of Understanding that the partners will sign in order to formalize the transnational collaboration. The MoU will also regulate common methods for assessing and recognizing skills acquired by the participants within each Country. In order to regulate the participation of the selected students, their parents will sign a Mobility Agreement with each Sending school, to formalize the acceptance of the European funding as it will inflected in the mobility services that the partnership will guarantee:

- -round flight price for all participants and accompanying persons from and to the hosting country;
- -accommodations for students and teachers during their stay abroad (it will be evaluated, together with the entire partnership, the possibility of involving the families for hosting foreign students);
- -meals in local restaurants or at schools' canteens (each NT is committed to ensure a good quality-price ratio so to maximize the project budget);
- -cultural activities (museums, parks, guided visits, etc.) during students' spare time abroad.

- -support its partners in the practical organization of the mobility when coming to its country;

- -fill in its own Mobility Tool by registering all the participants, coming from the sending school and taking part in the LTTAs;

How did you choose the project partners? Does your project involve schools that have never participated in a Strategic Partnership? If yes, please explain how more experienced schools can support less experienced partners during the project.

The Art School "C. Brailoiu" has no previous expertise in the management of Erasmus+ projects so when it decided to apply for the programme funding to increase the learning opportunities at its pupils' disposal, it was strategical to search for more experienced partners which the Applicant School could learn from. Through the European dissemination platforms and previous connections, the Romanian NT managed to establish contacts with schools coming from all Europe and form the present Strategic Partnership based on the following decision-making process:

-first, it was identified the decision to build up a "mixed work team" that could bring its own different personal experience in the project management and favour the general transfer of knowledge. To keep it balanced, the partnership is now consisting of 1 school with little experience (Hyvinkään yhteiskoulun lukio) in the organization of transnational actions and 2 that already participated in more than one Erasmus+ funded projects (Escola Básica de Pedome and Bergama Cumhuriyet Anadolu Lisesi); during the project development, more experienced schools will support the ones that are less experienced by sharing their previous know-how in daily decisions and project meetings, producing a personalized knowledge transfer mechanism which will result in better assimilation/ creation of new knowledge;

The project activities will involve 84 students (21 per school), 7 pupils selected by each school for each LTTA to be developed in mobility mode; if hosting, the schools will still involve 7 local students so that actual number of pupils involved will increase to 112 divided into delegations of 7 students per each LTTA, accompanied by 2 teachers. For the students' selection, each partner school will issue a Call for Application, promoted during specific Info-Days planned to engage the entire school community and pupils' families as well as through an online dissemination strategy.

A Selection Committee, made up of each NT and the Principals of each school partner, will evaluate the applications received based on the following criteria: motivation to take part in the experience, measured through one-to-one interviews (min. 5 - max. 10 points); knowledge of English – B1 will be the minimum CEFR level required, to be assessed on their listening and speaking (min. 10 - max. 20 points).

Students with migratory background and economic obstacles (I.e. family yearly income lower than €20,000) will be asked to present evidence of their conditions and attach relevant documents to their application.

For teachers interested in participating as "mobility facilitators", a specific Letter of Support format will be made available for the candidates; accompanying teachers will be identified on their participation in previous exchanges and according to their level of English. In the framework of the project, all the mobility facilitators will be engaged in preparatory activities developed by the Applicant school on the European Agenda for Music;

The partnership foresees the development of the following preparatory activities for the students:

-Cultural preparation: teachers and students will be presented with the schools that will host the training through video calls, and each NT will take care of illustrating the main cultural features of the destination countries. This will also be an opportunity to reflect on everybody's expectations, including learners' families. (overall duration 8h - 2 meetings of 4h):

-Language Awakening: considering that English will be used as main communication means, it will be necessary to stimulate its use and activate students' schemata to facilitate real-life interactions. Hence, a Peer Education System (PES) has been evaluated as a valid instrument to encourage students' "language awakening" and, at the same time, empower inclusion and teamwork. The PES will allow foresee the development of an eTandem Language Learning experience (by e-mail, phone or other media) that will accompany students in their pre-mobility preparation in the 3 months (no. 5 weekly interactions in the 3 months prior to departure);

-a series of eTwinning virtual exchanges (open to the non-beneficiary students as well) will enrich the students' preparation as clarified in the following paragraphs.

#### Description of the activity:

The first LTTA will take place in Turkey, at the premises of the Bergama Cumhuriyet Anadolu Lisesi, that will host 3 delegations of 7 students coming from Romania, Finland and Portugal. The Turkish school, with the support of the entire partnership, will lead learning activities aimed at integrating music in the teaching of STEM disciplines and make that link explicit to students. The activities will develop according to the following program:

Day 1: arrival in the hosting country and transfer to the accommodation;

Day 2: ice breaking activities to promote participants' integration in the work teams; outdoor discovery games to help students get acquainted with the new environment; presentation of the project to the Turkish school community;

Day 3-4: students, divided into mixed groups, will carry out tasks and exercises combining Mathematics/Engineering and Music (i.e. on rhymes structure, poetic notes, mathematical principles of sound, frequency and harmony, tuning systems, acoustic engineering, equalization, etc.); the aim will be to motivate students in the learning of mathematics through music and songs, which have the potential to become a learning tool that pupils can use on their own; the integration of ICT in the learning environment will also contribute to the development of new digital skills; at the end of each activities, learners will be invited to reflect on their learning process through self-assessment grids;

The Core Objective and Area of Action considered to prepare learners for the topics of C1 will be "Education and Access to Music" and "Technology".

#### **Description of the activity:**

- Describe the content, methodology and expected results of the activity.
- How is it going to be related to or integrated with the normal activities of the involved schools?

The second transnational exchange of groups of pupils (LTTA C2) will be hosted in Finland by Hyvinkään yhteiskoulun lukio and it will focus on the connections existing between music and foreign languages (the LTTA was assigned to the Finnish partner school in consideration of its experience in teaching different languages). LTTA C2 will develop according to the following programme:

Day 1: arrival in the hosting country and transfer to the accommodation;

Day 2: ice breaking activities to promote participants' integration in the work teams; outdoor discovery games to help students get acquainted with the new environment; presentation of the project to the Finnish school community;

Days 3 – 4: on the first two days of training, pupils, divided into small mixed groups, will carry out tasks and exercises aimed at discovering musical patterns behind languages (i.e. tasks on intonation, tone, stress, rhythm, etc.); the aim will be highlighting the general capacities shared by language and music, and invite students, through moments of self-evaluation and assessment, to reflect on the cognitive domains activated by both;

Day 5-6: the last 2 training days will be aimed at giving pupils concrete tools that can make them more independent and autonomous in their learning language. In fact, music offers many advantages for learning languages according to many scientists that have shown that listening to a song and humming along can help with language learning. Songs to learn new L2 vocabulary in context, to help improve pronunciation and listening skills (listening for gist, for specific information, to deduct and inference). Teachers will suggest and have students practice with apps, software, virtual games, and websites that they can resort to in their future for their lifelong language learning. Pupils will find out that music and songs are a tool for self-study, which will fuel their motivation and learning accountability.

Day 7: departure to the home countries.

The expected results of LTTA C2 will be:

- -100% of students will show greater curiosity towards new cultures and foreign languages;
- -100% of pupils will become more responsible for developing their own self-efficacy and taking the initiative to follow through with the application of learned content and skills;

In the preparation phase for the second transnational exchange, students from each school will use eTwinning to focus on those Key Themes, taken from the European Agenda for Music, that are more interconnected with the topics of C2. Specifically, students will develop constructive debates by starting from the analysis of one of the EAM Core Objectives and specified Means: "Diversity" and "Cooperation & Partnership".

The activities will also give participants a deeper awareness of multiculturalism and of the unifying power hidden in music and its cultural varieties. A self-assessment will be prepared for all the students taking part in the virtual exchange to give them (and those that will not take direct part in the LTTA) the chance to take control of their own learning and manage their own future development more independently. #### Description of the activity:

The third transnational exchange will be hosted by the Escola Básica de Pedome, in Portugal, and will focus on the link between music and sport/well-being. The low levels of physical activity among adolescents in the EU are alarming (up to 80% of teenagers only practice sport in school) so it is necessary for schools to promote physical education and encourage learners to reflect about different lifestyle choices in relation to physical activity, stress management and general wellbeing.

LTTA C3 will develop according to the following programme:

Day 1: arrival in the hosting country and transfer to the accommodation;

Day 2: ice breaking activities to promote participants' integration in the work teams; considering the pivotal role of the LTTA (being C3 the second to last mobility), a presentation of the activities developed until now will be delivered to the school community as well as a recap on the state of the art of the realization of O1 and O2;

Day 3-4: the first two training days will be destined to investigate the benefits of music in sport (i.e. stop negative thoughts, activate autopilot, feel fitter, emotions control, etc.); by applying a flipped classroom approach, students will first examine web sources provided by their teachers and create a basis of knowledge on which it will be possible to establish debates. Debates will help students improve critical thinking skills, acquire better speech delivery and public speaking, enhance teamwork skills and collaboration;

Day 5-6: the last two training days will be aimed at practicing dynamic tasks that will highlight the ergogenic effects related to the use of music to improve physical performance and provide more endurance, power, productivity, and strength; students will conduct outdoor activities aimed at experimenting music and movement, guided by experts, scientists and professionals, and how music impacts on their body and focus (i.e. the study case of binaural beats that are claimed to induce positivity and creativity). Post-task Self-assessment activities will lift the role of students from passive to active learners.

Day 7: departure to the home countries.

- -80% of participants will acquire soft skills such as time/stress management and problem solving;

#### **Description of the activity:**

The last transnational exchange (LTTA C4) will be hosted by the Applicant School, the Liceul de Arte "C. Brailoiu", in Romania; it will be aimed at rounding off the project activities by organizing tasks linking music to its most akin topic: Art. Being an expert in teaching art, drama, music, the Romanian Applicant school will lead the activities with the support of the entire partnership. LTTA C4 will develop as it follows:

Day 1-2: arrival in the hosting country; recap of the eTwinning virtual exchange organized before the last LTTA as preparatory activity; ice breaking tasks to promote participants' integration in the work teams and establish an atmosphere of cooperation:

Day 3-4: students, divided into mixed groups, will develop tasks and exercises aimed at researching and investigating the relationship between music and visual arts, i.e. simulations will allow students to become "art critiques", and analyze different paintings by W. Kandinsky, considered the painter of sound and vision. Hence, the first two days of LTTA will be destined to develop learners' knowledge on the existing links between arts and music, while the last training day will be aimed at the acquisition of competences and skills supporting learners in the empowerment of their own creativity;

#### Follow-up

How are you going to assess if the project's objectives have been met?

In order to evaluate the results produced by "LE.IT.M.O.T.I.V. – LEarning how to InTegrate Music in schOol Through International Ventures", the partner schools involved in the transnational collaboration will plan a monitoring and evaluation action that will cover the entire duration of the activities.

The monitoring will be carried out by the NTs and accompanying teachers during the student's mobility phases and, on a higher management level, by the Applicant School during the project meetings and daily interactions. Pupils will be asked to fill in online questionnaires to assess their level of satisfaction, before, during and after the transnational exchanges; questions destined to pupils will target aspects concerning the quality of the mobility services, information and training provided as well as the perception of their own improvement.

Teachers will do the same in order to assess the management that they will put in place to organize the project activities and level of satisfaction about their experience as "mobility facilitators". This will be achieved through the submission of Evaluation Grids that will allow teachers to express their opinion on: the efficiency of internal and external communication; the quality of the cooperation; the effectiveness of the monitoring and risk management plan implemented.

Interim evaluation meetings and daily communication among the partners will complete the project evaluation process, finalized in the Final Report that the Applicant School has the responsibility to submit within 2 months from the project end date (and that will represent a further self-assessment tool for the entire partnership). A middle-long term evaluation will be conducted by each NT to measure the impacts achieved within 6-12 months following the end of the activities. The overall quality of the project will be assessed on the following indicators:

- -% of participating students that will improve their school results;
- -% of participating teachers who will integrate Music into their teaching routine to promote their learners' motivation towards the study of STEM disciplines, foreign languages, art and sport;
- -% of participants who will improve their proficiency in L2 or choose to study a foreign language;
- -no. of didactic activities launched by the partner schools to enhance the integration of Music in extra-curricular time;
- -no. of transnational cooperation projects proposed by the partner schools (including those to be developed on the eTwinning platform);

How will the participation in this project contribute to the development of the involved schools in the long-term? Do you have plans to continue using the results of the project or continue to implement some of the activities after the project's end?

The present Strategic Partnership share the need to include training activities based on the integration of Music into daily teaching according to an interdisciplinary approach and in order to motivate students in their learning process as well as future development.

Planning a preparatory moment for accompanying teachers and educators involved in the NTs, but also for whoever from the school community will manifest interest in participation, teachers will discover new ways to access and assess teaching, fostering their own continuing professional development. In addition, the knowledge acquired will be consolidated through direct organization and observation of the didactic approaches applied abroad during the LTTAs. Upon returning, teachers engaged in the project will draft a list of "Lessons learnt" to be shared with the rest of the school staff (and on the European dissemination platforms so that results will be made available for all the online community of educational stakeholders).

In the long-term and in order to contribute to the improvement of the involved schools, an Alumni Group will be founded with the purpose of creating a "transnational space" that teachers and educators can use to debate and discuss about new didactic methodologies, thus maintaining the sustainability of the cooperation activated and ensuring the faster internationalization of the Educational Plans of "Bergama Cumhuriyet Anadolu Lisesi", "Hyvinkään yhteiskoulun lukio", "Escola Básica de Pedome" and, last but not least, the Applicant Art School "C. Brailoiu".

The frequent use of eTwinning in the project dynamics will allow the deeper mastery and integration in daily didactics, increasing exchanges of good practices among students and teachers while also digitalizing the learning experience for each partner school; digitalization and progressive improvement will find sustainability in the use of the platform of School Education Gateway for the creation of the MOOC. In fact, one of the project outputs will be the creation of an online course aimed at sharing, with other European teachers and educators, methods and activities to use Music in classrooms for motivating learners. The MOOC will be finalized by the end of the project end and will follow the structure of other MOOCs promoted on the platform (confirmed publication of the online course will depend on the Teacher Academy Pedagogical Advisory Board). The created MOOC will be used in the future to innovate the didactic approach of new teachers and enrich further support actions in the framework of new Erasmus+ projects, school local activities, etc.related to Music and Art Education.

"LE.IT.M.O.T.I.V." will be launched during open events held at each school's premises in order to spread it within the local community and engage specific Target Groups (TG): TG1 - members of the NTs; TG2 - teachers and students inside each school and possible candidates for mobility activities; TG3 - families belonging to school communities; TG4 - Schools and training organizations at local and European level; TG5 - professionals, experts and policy makers. Indeed, each partner school counts a wide network of families, educators, professionals, companies, associations normally engaged in extra-curricular activities, that will be involved in the project through the organization of specific activities following a Communication and Dissemination Plan (CDP). The CDP will be drafted with the contribution of all the partners involved and will foresee personalized activities for each Target Group identified:

- -use of instant messaging tools for the rapid dissemination of the results achieved within the partnership (TG1); -use of the school official websites (TG2-3);
- -creation of project social pages on Facebook and Instagram (TG2-3) and use of European dissemination platforms such as eTwinning, School Education Gateway, but the Erasmus+ Project Results Platform (TG2-3-4);
- -monthly newsletter sending communications on the project progress to all the stakeholders that usually gravitate around each school (extra) curricular activities, etc. (TG5);
- -launch of a project website that people can have access to in order to use the materials produced in the framework of the project (TG1-2-3-4-5).
